Allen County Community College Quality Initiative (QI), Institutional Data Improvement and Utilization focused on data collection, analysis, reporting, and utilization of institutional data. The College has used a variety of human, financial, physical, and technological resources to ensure that data-informed decision-making is possible in the current culture of the institution.
